

## Report on the workshop organised by the Departments of Management Studies and Commerce on 21-12-2022

The Department of Management studies and Commerce in association with IQAC organised a workshop on Intellectual Property rights on 21-12-2022. The workshop is to focus on to create awareness to the students on the concept of Intellectual Property Rights and the increasing significance of intangible assets in the global economy is forcing business organizations to actively manage their IP as a key driver for building and sustaining their competitive advantage and achieving superior performance.

The session began with the opening remarks of the chairman of the workshop and principal of the college Dr. Y.V.V.App Rao. He explained the concepts of Intellectual Property Rights and contemporary issues in Intellectual Property Rights of today's times.

Later IQAC Co-ordinator & Head of the Department of English explained the today's globally competitive environment, intellectual property has placed itself on a pedestal in the context of economic growth and is becoming increasingly important and Intellectual Property (IP) is the fuel that powers the engine of prosperity, fostering invention and innovation.

Later the students of MBA Mr. G.V.S. Ganesh and Mr. N. Rajkumar introduced the resource person Dr. G.V.S. Sarma Associate Professor Department of Chemical Engineering, Andhra University, Visakhapatnam to the participants.

In the morning session the first resource person Dr. G.V.S. Sarma Associate Professor delivered the lecture on the topic. He explained the Basic concept in IPR, Objectives in IPR, Type of IPR (Patents, Trademarks, Copyrights And Related Rights, Geographical Indications, Industrial Designs, Trade Secrets, Layout Design For Integrated Circuits, Protection of New Plant Variety), Duration of Intellectual Property Rights, Concept Related Patents (Types of Patent, Tangible And Intangible Property, Novelty, Non-Obviousness, Utility, Anticipation, Prior Art, Global Perspective of Patent System, Role of International Organization, Indian Patent Act 1970, Patentability, Patent Infringement, Commercialization, Patent Licensing), Applications of IPR.

In the afternoon session the second resource person Dr. K. Chiranjeevi delivered his talk on intellectual property rights (IPRs) has become one of the hottest, most significant issues of trade negotiations. Despite the continued claim that IPRs facilitate research activities and encourage technology transfer, the impact of IPRs on socio-economic development process of developing countries has evidently reflected in many areas, including health, agriculture and education. IPRs will no doubt continue to have a significant impact on developing countries for many years to come.

Nearly 90 students are attended from the Department of Management Studies and Commerce. It was a valuable informative sessions, all the participants provided certificates at the end of the workshop.
